1. Artists must be able to communicate via email and be capable of sending digital images. You will send 5 or more images of art that represents what you would like to show (please include sizes and medium) along with this finished application to suzanne.becque@gmail.com.

2. We expect you to have a Maine Sales Tax Account. Each artist is responsible for reporting and paying State sales tax. **We require that you provide us with your Sales Tax Account Number before your first show.** Link to Maine.gov where you can apply: <https://www.revenue.maine.gov/#1>

3. Work must be properly presented and hung, in a manner appropriate to the medium, with an emphasis on frames and protective glass when appropriate. Artists are responsible for hanging their own work in assigned spaces. All work must hang securely on hooks (for panels) or a nail or be securely fastened/mounted to guarantee the safety of the art work, the safety of the viewers and minimize the liability of the barn owners.

Are you able to prepare your work according to the above criteria and hang it at the assigned time (we can be somewhat flexible) before the show?
